4. It is resolved to approve the detailed Syllabi for Part-IV Skill Enhancement courses for Semester I and II.

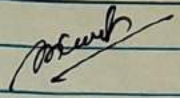
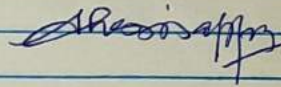
