  - v. Modify the syllabi of the course MARKETING MANAGEMENT and give room to introduce the concept of MARKETING 4.0.
  - vi. Consider reframing the syllabus of INTERNATIONAL FINANCIAL REPORTING STANDARDS, SECURITY ANALYSIS AND PORTFOLIO MANAGEMENT and INTERNATIONAL FINANCIAL MANAGEMENT
