1. Approve the rules and regulations for the students admitted in Bachelor of Business Administration from the Academic year 2017-18 and onwards.

 ⇒ Since two Finance specialisation papers were opted in Semester IV, the board recommended to shift core X: Financial Management course to Semester III as core IX.
3. Approve and adopt the detailed syllabi for Part: I Language courses (Tamil-I and Tamil-II) for semester: I and Semester: II being offered by the Department of Tamil.
4. Approve and adopt the detailed syllabi for Part: II English courses (English-I and English-II) for semester: I and Semester: II being offered by the Department of English.
