 - In Semester IV Core XIV Corporate leg, Units III & IV can be interchanged as Units IV & III (Valuation of Goodwill & Shones in Unit IV & Final b/c of Co's in Unit III).
 - In Semester V Core XXVI, the rules governing the evaluation of ⁽²⁶⁾ apprenticeship Training Report, the Rule No. 1 is modified as "Each student should undergo 100 hrs of apprenticeship Training in audit firms."
 - In Semester III Core VIII Company Law Paper, Unit-I can be redrafted to avoid the repetition in Unit V in Mercantile Law Paper in (Core VII) in II Semester.
 - In Semester VI Core XXXII Capital Market paper can be shifted to Skill Enhancement Course III and the Skill En. Course III GST is shifted to Sem VI as a Core paper ⁽³²⁾ XXXII.
- * Resolved and approved the question paper pattern for ⁽³²⁾ theory/ Practical/ proj work/ BPP. Training courses for both CIA & ESE.

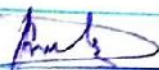
The following Suggestions were offered by the Members of Board for all UVI programmes:
